

**SUMMARY ANNUAL REPORT  
FOR IBEW LOCAL NO. 102 WELFARE FUND**

This is a summary of the annual report for the IBEW LOCAL NO. 102 WELFARE FUND, EIN 22-6487222, Plan No. 501, for the period January 1, 2021 through December 31, 2021. The annual report has been filed with the U. S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$116,493,723, as of December 31, 2021, compared to \$122,826,342 as of January 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$6,332,619. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$58,803,578 which included employer contributions of \$52,441,361, participant contributions of \$1,412,245, realized gains of \$4,606,138 from the sale of investments, unrealized depreciation in the value of investments of \$2,174,463 and earnings from investments of \$2,518,297. Plan expenses were \$65,136,197. These expenses included \$3,492,828 in administrative expenses, \$61,643,369 in benefits paid to or for participants and beneficiaries, and \$0- in other expenses.

If you request a copy of the full annual report from the plan administrator, these two statements and the accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
