UAW GROUP HEALTH AND WELFARE PLAN SUMMARY ANNUAL REPORT FOR THE PERIOD JANUARY 1, 2022 TO DECEMBER 31, 2022

TO: HEALTH AND WELFARE PLAN PARTICIPANTS

FROM: THE TRUSTEES

This is a summary of the annual report for the UAW Group Health and Welfare Plan, Employer Identification Number 22-3789539 Plan No. 501 for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust. Plan expenses were \$16,747,402. These expenses included \$15,509,113 in benefits paid to or for participants and beneficiaries and \$1,238,289 in administrative expense. A total of 821 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$8,186,513 as of December 31, 2022, compared to \$8,651,019 as of January 1, 2022. During the plan year, the plan experienced a decrease in net assets of (\$464,506). The plan had total income of \$16,282,896 including employer contributions of \$14,119,826, employee contributions of \$1,302,193, a realized (loss) from the sale of assets of (\$12,649), earnings from investments of \$53,673 and other income of \$819,853.

INSURANCE INFORMATION

The plan has contracts with insurance companies to provide certain benefits. These companies along with the premiums paid for the year ended December 31, 2022 and the benefits provided are as follows:

The Plan also provided for certain self-insured medical claims incurred under the terms of the plan.

The total self-insured benefits paid for the year ended December 31, 2022, was \$14,771,318.
