

**SUMMARY ANNUAL REPORT  
FOR IBEW LOCAL 456 SUPPLEMENTAL WELFARE PLAN**

This is a summary of the annual report of the IBEW Local 456 Supplemental Welfare Plan, EIN 20-0500732, Plan No. 502, for period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The IBEW Local 456 Supplemental Welfare Fund has committed itself to pay certain health and welfare coverage claims incurred under the terms of the plan.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$12,266,151 as of December 31, 2016, compared to \$11,462,811 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$803,340. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,187,012 including employer contributions of \$526,525 and earnings from investments of \$660,487.

Plan expenses were \$383,672. These expenses included \$6,000 in administrative fees, \$342,497 in benefits paid to participants and beneficiaries, and \$35,175 in other expenses.
