**Summary Annual Report for
LOCAL 94, IBEW HEALTH AND WELFARE FUND**

This is a summary of the annual report for LOCAL 94, IBEW HEALTH AND WELFARE FUND, EIN 22-6699169, Plan Number 501, for the period July 1, 2021 to June 30, 2022. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has (a) contract(s) with HORIZON HEALTHCARE SERVICES, INC., INTERNATIONAL HEALTHCARE SERVICES, INC., USABLE LIFE, and HORIZON INSURANCE COMPANY to pay the following types of claims incurred under the terms of the plan:

The total premiums paid for the plan year ending June 30, 2022 were \$5,671,062.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$17,398,645 as of June 30, 2022, compared to \$17,970,344 as of July 1, 2021. During the plan year the plan experienced a change in its net assets of \$-571,699. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$10,188,046 which included employer contributions of \$11,558,527, employee contributions of \$43,804, other contributions of \$0, gain/loss of \$347,576 from the sale of assets, and earnings from investments of \$-1,761,861.

Total plan expenses were \$10,759,745. These expenses included \$664,688 in administrative expenses and \$10,095,057 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
