

## Summary Annual Report

### REFRIGERATION, A/C & SERVICE DIV. (UA-NJ) ANNUITY PLAN

This is a summary of the annual report for the REFRIGERATION, A/C & SERVICE DIV. (UA-NJ) ANNUITY PLAN, (Employer Identification No. 22-2585171, Plan No. 002) for the period February 28, 2021 to February 28, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$15964699. These expenses included \$283650 in administrative expenses and \$15681049 in benefits paid to participants and beneficiaries. A total of 2227 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$342272565 as of February 28, 2022 compared to \$330163050 as of February 28, 2021. During the plan year the plan experienced an increase in its net assets of \$12109515. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$28074214, including employer contributions of \$14145127, earnings from investments of \$13563424 and other income of \$365663.

The plan has contracts with Prudential Retirement Insurance and Annuity Company, and Massachusetts Mutual Life Insurance Company which allocate funds toward individual policies.

#### MINIMUM FUNDING STANDARDS

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
